

## **COMMERCIAL DOCK APPLICATION**

**In order for an applicant to receive a commercial dock permit from South Carolina Electric and Gas Company (SCE&G) the applicant must meet the following terms and conditions.**

- 1. Necessary permits from the Corps of Engineers.**
- 2. Necessary permits from the State of South Carolina.**
- 3. Documentation from local zoning and building authorities showing Any other governmental permits or authorizations which may be required. Applicant has the sole responsibility to determine what requirements apply and to meet them. No statements by SCE&G personnel as to what is believed to be required in the way of governmental approvals can act as a waiver of any requirement not mentioned.**
- 4. An annual permitting fee will be charged by SCE&G Company and will be \$15.00 per slip per year. SCE&G Company will have the right to vary the amount of permitting fees from time to time.**
- 5. The applicant must furnish the Secretarial Department of SCE&G Company a copy of Insurance Policy of Public Liability and Property Damage (amount of coverage determined by Secretarial Department) along with two (2) copies of the Certificate of Insurance.**

**Applicant must agree to indemnification and insurance requirements as follows:**

**“The Permittee hereby agrees to indemnify and hold the Company harmless from any loss resulting from bodily injuries (including death) or damages to property, or any claims or suits against the Company, including attorneys fees, arising directly or indirectly out of any act or failure to act on the Permittee’s part, or the part of any agent, servant or subcontractor of the Permittee, whether independent or otherwise, in performance of the work undertaken under this Permit, or preparing to perform such, or cleaning up or leaving the scene after so doing, or in the operation of the facilities permitted.**

**“The Permittee would be allowed to name South Carolina Electric & Gas Company, Post Office, Columbia, South Carolina 29218, as an additional insured under the Public Liability or Property Damage policy instead of purchasing the Contractual Liability and Property Damage Endorsement to their policy. However, in no event will we exclude both of these requirements.**

**The Permittee shall, before commencing any work under said permit, deliver to the Risk Management and Pension Department of South Carolina Electric & Gas Company, Columbia, SC 29218, two (2) copies of a Certificate of Insurance completed by his insurance agent or carrier certifying that minimum insurance coverages as required above are in effect and will not be cancelled or changed until ten (10) days written notice is given to the Risk Management and Pension Department of South Carolina Electric & Gas Company.”**
